In addition, I will not conduct any defense marketing activity as defined by the Defense Export Control Law, 5776-2007.
3. I understand and agree that any action that I will take in order to inspect the Deliverables during the Acquaintance Tour is on my own responsibility;
4. It is agreed that I will be fully liable for any loss and/or damage caused to me during the Acquaintance Tour.
5. I declare that I and /or my dependents and/or heirs shall have no claim against the IMOD or any servant or agent of the IMOD in respect of any damage or

injury sustained to me howsoever occurring in consequence of the Acquaintance Tour or of anything done or suffered during the Acquaintance Tour;

6. I and/or my dependents and/or heirs shall hold the IMOD harmless against any claim filled by me and/or my dependents and/or heirs in respect of any damage or injury (including death) which may occur to me during the Acquaintance Tour and/or as a result of, or in connection with the Acquaintance Tour.
7. It is further agreed and declared that in case of any claim or demand filled by any entity or person against the IMOD in consequence with the damage or loss described on section 2, I and/or any dependents and/or heirs will fully indemnify and/or compensate the IMOD for any amount which the IMOD will pay in connection with the claim or demand.
8. This undertaking shall be construed and have effect in accordance with the Israeli Law and shall be subject to Israeli courts only.
