



Security-sensitive Post Candidate/Employee: Personal Questionnaire for Partner (foreign citizenship holder only)

Guidelines

Dear Sir/Madam,

1. Your partner is a candidate for/holds a position that requires security clearance, for which s/he is being vetted.
2. As part of the security check, you are required to take part in the process your partner is undergoing.
3. Your willingness to cooperate with this process has direct bearing on your partner's chances to complete the vetting process as quickly as possible.
4. The stages of the process you will be participating in are as follows:
 - 4.1. Filling out a personal questionnaire as the partner of a security-sensitive post candidate/employee.
 - 4.2. In accordance with the information received in this process, you may be called for further clarifications.
 - 4.3. Kindly include a copy of your ID/passport with the questionnaire.
5. Please be advise that the personnel handing the information shared in the vetting process is highly sensitive to individual privacy, is respectful of it and is obligated towards maintaining its confidentiality.

- Have you ever belonged to an entity engaged in espionage or violent protest?
