**hereby declare, undertake and agree as follows:**

1. To honor and to comply with all the provisions of the law, including, in particular, laws relating to representation with the objective of bringing about a labor relationship connection, in the scope of performing my activities as an intermediary. In addition, I agree that the bylaws of the Association will be binding on me, and the FIFA bylaws and rules will also be binding on me in connection with my activities as an agent.
2. I do not currently hold and during the 12 months preceding the date of signing of this declaration I have not held any position, and I do not hold any office in the scope of the Israel Football Association or any other football association, or any football team in Israel or abroad. Likewise I confirm and undertake that I will not fulfill and will not hold any such function or position during a period of 12 months from the date on which the transaction in the scope of which I served as an agent is approved or reported (or was supposed to have been reported) to the Budget Control Authority.
3. I have never been convicted of a criminal offense connected with violence or financial matters.
4. I have no contractual relationship with the League Administration, the associations, confederations or with FIFA which are likely to cause a conflict of interests. In the event of uncertainty regarding the question as to whether relationships which I have with any such entity exist, I will disclose

those every relevant agreement to the Association, and such agreement or details of the connection are attached as an integral part of this declaration.

5. I have not received and I will not receive any payment, directly or indirectly, which will be paid by one football team to another football team in connection with the transfer of a player in the scope of the transaction in which I served as an agent, such as payment to a team in respect of a future transfer or future loan of a player, payment in respect of training and advancement of the player in accordance with the FIFA bylaws, or solidarity payments in accordance with the FIFA bylaws and amounts that may be paid pursuant to a ruling of the Player's Status institution of the Association. These amounts will also not be taken into account for purposes of determining the agent's fee that will be due to me.
6. I will not accept any payment from any party if the player in question is a minor.
7. I will not take part, directly or indirectly, and I will not be connected in any other manner, in illegal gambling as defined in the Penal Law (Consolidated Version, 5737-1977), and I will not participate in legal gambling connected with matches of the player or the team which I represent or which I represented, save and except wagers in the framework of "Toto 16".
8. I give my irrevocable consent to the Association receiving full particulars about any payment of whatsoever nature that may be paid to me by a club or by a player for my services as an agent.
9. To transfer to the Association all the contracts, the agreements and the records in connection with my activities as an agent. I further agree that the Association will receive any document from any other party who advises, enables or takes any active part in the negotiations for which I am responsible.
10. That the Association will retain in its possession and will publish all the data mentioned in the aforesaid agreements, including on its Internet website.
11. That the Association will publish details about all the disciplinary penalties that have been imposed on me or disciplinary measures that have been taken against me, if there were such, and will report thereon to FIFA.
12. I am fully aware and I agree thereto that this declaration shall be at the disposal of the authorized bodies of the Association.
